Governing Board

The Governing Board defines the policies and strategies of Eurogas and determines the budget and financing, which are then submitted to the General Assembly for approval.

The Governing Board is chaired by the President, who is elected every two years, and an elected Board composed of representatives of Eurogas member companies, associations and federations.

The General Assembly sets out the association's objectives, monitors its activities, approves the annual budget, and elects the President and Board members.
